

The following tables list the individual data elements that currently exist as part of the CII/CPAR data specifications from Alberta Health.

## Encounter Data Elements

Table 1 data elements come from the EMR extract patient encounter level file submitted by the participating clinics.

The EMR extract file was built from the foundational *Canadian Institute for Health Information (CIHI) Primary Care EMR Data Content Standard* which was approved in draft for use in Alberta by the Health Information Standards Committee for Alberta (HISCA) in 2013. As part of the CII/CPAR Limited Production Rollout phase, continued assessment and evaluation of the data content standard is being done to determine relevance and fitness for use of the current standard. Any field which is flagged as confidential in the EMR, will not flow to Alberta Netcare.

## Panel Data Elements

The panel data elements listed in Table 2, are uploaded to the Central Patient Attachment Registry (CPAR) as part of the overall paneling process. Primary providers that maintain patient panels in their Electronic Medical Record (EMR) can have their panels automatically uploaded to CPAR. The data elements are extracted from the information entered and maintained in the EMR for each patient on the provider's panel. Confirmed patient attachments to primary providers is a key enabler for continuity of care, and a foundational element of the Patient's Medical Home.
